## Re-engagement of retired Railway Senior & Junior Scale officers of Accounts as Consultants(Accounts) in Junior Scale in Northern Railway

Date of issue: 01.05.2019

Closing Date: 15.06.2019

In continuation to this office's advertisement published on 27.04.2019, it is intimated that the last date for sending the applications in prescribed proforma invited for the 03 posts of Consultants (Accounts) in Junior Scale only in Accounts Department, from the retired Railway Accounts Senior & Junior Scale officers for re-engagement on monthly remuneration basis for Northern Railway, is now extended up to 15.06.2019.

Terms and conditions, eligibility criteria, rate of monthly remuneration and the Prescribed Proforma etc. are available on official website. Interested retired Railway Accounts officers may download the Proforma and send their application to office of PFA, Northern Railway, Baroda House, New Delhi-110001, before the closing date i.e. 15.06.2019. For details, Northern Railway website <u>www.nr.indianrailways.gov.in</u>. may please be visited.

In case of difference between English and Hindi, the instructions of English version shall be considered relevant.

Subject: Procedure and Guidelines for Re-engagement of retired Railway Accounts officers as Consultant (Accounts) in exigencies of service.

Railway Board vide their letter NO.2018/Trans Cell/S&T/Contractual Staff dated 25-10-2018 has conveyed the approval of re-engagement of retired officers in Junior Scale(only) as Consultants in exigencies of services against the vacant posts and General Managers/PHODs are empowered to re-engage retired officers.

Further, in order to re-engage retired Railway Accounts officers in exigency of service due to acute vacancies of Gazetted officers in Accounts Department, this document lays down comprehensive guidelines pertaining to it.

The scheme of re-engagement of retired railway accounts officers shall henceforth be regulated as per the following guidelines.

## **1** General Conditions for Re-engagement of Retired Railway Accounts Officers :

The appointment of retired officers is temporary in nature against the specific jobs or against identified vacancies. In general the guidelines for re-engagement of retired officers will be as per the policy laid down as per Railway Board letters with reference to maximum time of re-engagement, remunerations etc., on re-engagement of retired officers.

### 2 <u>Period of Re-engagement:</u>

- (i) Maximum age limit for which re-engagement shall continue will be 65 years or validity of the scheme of re-engagement of retired employee which is two years i.e. upto 25.10.2020 or on joining of selected candidates from UPSC/Departmental selection (70% Selection & 30% LDCE) or in case of unsatisfactory service whichever is earlier or as governed by the instructions issued by Ministry of Railways from time to time.
- (ii) The engagement of retired staff can be terminated by the Department/office at any time without assigning any reason thereof However, retired officer will be given 7 (Seven) days advance notice or remuneration in lieu thereof before termination from the engagement.
- (iii) If the re-engaged officer, remains absent from duty without prior intimation (i. e beyond the period of permitted leave as detailed at (9) below), his/her services shall be liable for termination without any prior notice. The competent authority in this regard shall be HOD concerned.

### 3 Age Limit

All the retired (Railway Accounts) officers who have not achieved 64 years 6 months on the last date prescribed for submission of application (to ensure at least Six months service is available after re-engagement) for re-engagement purpose will be eligible for re-engagement.

### 4 Eligbility Criteria

- (i) The retired officer should have normally superannuated as Railway Accounts officer in the same category or above. He/she should not have been compulsorily/Voluntarily retired/removed/terminated from service etc. and should be free from Vigilance/SPE or departmental enquiry and criminal proceedings at the time of retirement.
- (ii) He/she should not have any police case at the time of re-engagement.
- (iii) He/she shall submit copy of Pensioner Identity card, PPO, service certificate and an Affidavit duly notarized declaring that no police case/criminal proceedings is pending against him/her at the time of re-engagement, along with the application.
- (iv) ACRs for the period up to 3 years preceding his/her retirement will be considered.ACRs should have at least been graded as 'Very Good' before retirement.
- (v) He/She should be medically fit for the category for which applying and Medical fitness certificate for the appropriate category should be obtained from the designated railway medical officer and submitted at Accounts Department , 4<sup>th</sup> floor, Northern Railway, Baroda House, New Delhi with the concerned authority.
- (vi) A retired officer who has been a member of any political party after his/her retirement shall not be eligible for re-engagement.

## 5 Jobs to be Discharged

- (I) A re-engaged appointee has to discharge such duties, and in such a matter, as may be prescribed by the concerned Department from time to time.
- (ii) Performance of an re-engaged retired officer shall be monitored rigorously by the Administrative Department against the targets/deliverables assigned to the re-engaged retired officer.

## 6 Procedure

- (i) The re-engagement will generally be against the vetted vacancies in the Junior Scale Cadre. At any point of time, total staff strength after reengagement should not be more than Sanctioned Strength + Resultant Vacancies in higher grade. Assessment of the vacancies may also include the requirement against retirements in the next quarter.
- (ii) Vetting of vacancies shall be done by "Personnel' branch within three days of receipt of details of vacancies from accounts department.
- (iii) Based on requirement and Terms of Reference, a notification (on- line/offline) shall be prepared for advertisement for inviting applications from eligible retired Railway Accounts officers.
- (iv) Wide publicity will be given to such re-engagement by putting notification via the Railway's web-site and by publishing the Notice in

Hindi/English/vernacular Newspapers and on the notice boards of Headquarter's office.

(v) All applications received in response to the advertisement will be processed with the authorization/approval of the concerned HOD as per their requirement. Thereafter, the proposals of applicants will be submitted before the nominated Committee which would recommend a panel of eligible candidates based on the suitability/competency of the applicants. The composition of the nominated committee will be as at (7) below. The Order of seniority on the Panel for re-engagement will be in order of higher residual service available to willing candidates on the date of formation of the Panel.

# 7 <u>Composition of Evaluation Committee to evaluate suitability of eligible</u> <u>candidates for Accounts department, shall be as under:-</u>

Evaluation Committee shall assess the candidates on the basis of 50 Marks which will be distributed as under :-

a) <u>APARs of last 03 years</u> : 15 Marks {5 Marks each of last 03 years APARs which will be marked as under:-

Outstanding: 05 Marks Very Good : 04 Marks } Less than Very Good:-Nil

b) <u>Years of experience in Gazetted Cadre of Accounts Department</u> : 15 Marks {to be evaluated as under:

With 05 or more years of experience:15 MarksWith less than 05 years of experience:10 Marks

c) Interaction : 20 Marks

On the recommendation of the Committee, Administration Section will process the case for approval of the Accepting Authority and on getting approval will issue offers to the selected candidates and issue re-engagement orders. Competent Authority for acceptance of recommendation of Committee will be PHOD.

### 8 Tenure, Terms and Conditions of Re-engagement of Retired Accounts Staff

(i) The appointment of retired officers is temporary in nature against specific jobs or against identified vacancies. He/she shall not be entitled for further employment in the Railways.

- (ii) The contractual appointment will be initially made for a period six months, extendable by spells of six months or less, depending upon satisfactory performance and shall not be extended beyond the age of 65 years or on joining of candidates selected by UPSC/Departmental selection, whichever is earlier, or as governed by instructions issued by Ministry of Railways from time to time.
- (iii) The engagement of retired re-engaged officer can be terminated by the Department/Office at any time without assigning any reason thereof. However, retired re-engaged officer will be given seven days advance notice, or remuneration in lieu thereof, of termination from the engagement.
- (iv) The Department may also terminate the services of retired re-engaged officer in case he/she is unable to achieve assigned works within prescribed time frame or the work assigned to him/her is not found satisfactory to the Department or he/she is found to be lacking in honesty and integrity.
- (v) Selected re-engaged retired officer can be posted anywhere in Northern Railway.
- (vi) Retired re-engaged officer may be required to perform assigned duties on Saturdays, Sundays and other Gazetted Holidays and beyond office hours, in case of exigencies of work. No extra allowances will be permissible for the same.
- (vii) The re-engagement of retired re-engaged officer shall be on full time basis and they shall not be permitted to take up other private assignment while they are engaged with the Department.
- (viii) The data collected as well as deliverables produced for the Department shall remain with the Department. No one shall utilize or publish or disclose or part with, to a third party, any part of the data or statistics or proceedings or information collected for the purpose of the assignment or during the course of assignment for the Department without the express written consent of the Department.
- (ix) Ministry of Railways/Northern Railway shall not be held responsible for any loss, accident, damage or injury suffered by the re engaged retired officer while executing their official duties.
- (x) Re-engaged retired officer shall be required to mark their attendance in the Biometric Attendance System.
- Monthly remuneration of a retired officer being re-engaged will be determined by reducing Pension from his/her last pay drawn(i.e. Basic Pay + DA) in terms of NR PS 14899/2018.
- (xii) The payment of remuneration to retired engaged staff will be through electronic mode.
- (xiii) Taxes as applicable shall be deducted from their monthly remuneration.
- (xiv) Nature of work shall be assigned by Railway Administration and can be changed as per administrative exigencies.

- (xv) The period of the contractual appointment shall not be counted as Government service for the purpose of pension or any other retirement benefits.
- (xvi) The retired officer must obtain the fitness in the suitable category in medical examination in Railway Hospital. For medical examination, they will deposit the requisite fee with Chief Cashier at any Railway Station and HQ office (Northern Railway) under Head Z-660.
- (xvii) The applicant will furnish an undertaking while filling the application in the prescribed Performa with regard to the truth and correctness of the information furnished by him/her and also submit at the time of joining the declaration of allegiance and secrecy as per Annexure II.
- (xviii) Any breach of information/declaration by him/her will lead to immediate termination of service without any prior notice.
- (xix) Re-engaged officer shall not be entitled for any consequential benefits apart from those explicitly stated in the Terms and Conditions of Notification.
- (xx) Re-engaged officer shall not be entitled for requisites such as HRA, CCA, Transport Allowance, Residential Accommodation, etc. However, when required to travel in connection with official work, TA/DA admissible to regular employee working in the same grade, will be admissible.
- (xxi) The designation of the re-engaged retired officer shall be Consultant (Accounts).
- (xxii) Consultant (Accounts) will not be given financial and D&AR powers and shall not be authorized to issue any safety certificate.
- (xxiii) Re-engagement retired officer shall be required to fill the allegiance and secrecy (Annexure-II).

#### 9 <u>Leave</u>

The re-engaged staff shall be allowed only 12 days of permissible leave in a Calendar year on pro-rata basis. However, if the re-engaged officer remains absent from duty without prior intimation (i.e. beyond the period of permitted leaves), his/her service shall be liable for termination without any prior notice. The competent authority in this regard shall be HOD concerned.

#### 10. Validity of the Scheme:-

This scheme of re-engagement of retired officers for Accounts department will be valid Only till 25.10.2020 (in compliance to Railway Board's letter No. 2018/TransCell/ S&T/Contractual Staff dated 25.10.2018).
